### **Disclosure on the processing of personal data ex art. 13 d.lgs. 196/2003 and art. 13 and 14 Regulation (EU) 2016/679**

We would like to inform you that the d.lgs. 30 June 2003 ("Personal Data Protection Code" or "Privacy Code"), as well as the Regulation (EU) 2016/679, provide for and guarantees the right to protection of the personal data that constitutes the subject of third-party treatment on the basis of the principle that anyone has the right to the protection of personal data concerning him and to the treatment of it in respect of fundamental rights and freedoms, the dignity of the person concerned, with particular privacy and personal identity.
